Tonight's update from Finance and Operations:

Goodnow Brothers Elementary School:

I have included a letter from the Massachusetts School Building Committee in your packets. The MSBA has approved Goodnow as a model school building. This program was created to effectively adapt and re-use the design of successful, recently constructed school buildings for future projects in the Commonwealth.

Food Services Participation:

Our foodservice program continues to see the benefits of universal school meals, with participation in school breakfast and lunch up since the pre-covid "normal" benchmark of FY20.

I will provide the School Committee with periodic updates on school meals participation rates district-wide, utilizing our last pre-Covid fiscal year as a benchmark. Below are the participation rates for September 2023.

September	FY20	FY24
Lunch Participation	56.9%	67.0%
Breakfast Participation	24.6%	47.0%

The district believes in providing our students with access to nutritious and appealing meals and will continue striving for a 75% participation rate in school lunch. I would like to remind families that school meals are included at no cost for all Marlborough students.

Assistant Superintendent of Teaching and Learning's Report to School Committee – Regular Session November 28th, 2023

Professional Development Update:

On November 7th, our district held a full professional development day that was split into a morning and afternoon frame of time. The morning sessions were a continuation of our Anti-Bias/Anti-Racist (ABAR) professional development that began back in November of 2021. Our high school educators explored some ABAR related topics more deeply, such as differentiated instruction for equity and understanding the challenges that our MHS students face. Our PreK-8 educators practiced with some of the ABAR lessons that have been created for our PreK-8 students. The first lesson of this three lesson series will be instructed in November/December of 2023.

We are very proud of the efforts of many of our staff members who have stepped-up to facilitate ABAR training sessions, as well as the efforts of our ABAR Steering Committee that has led this work.

The afternoon sessions were a variety of offerings from our MPS Choice Catalogue. There were 32 total workshops of which the majority were led by Marlborough staff. We are looking forward to another full day of professional development later this school year in March.
